Cookie Policy

In the event of any conflict between the English and German versions of this Cookie Policy, the German version shall prevail.

This Cookie Policy sets out our policy with respect to information we collect about you on our website, applications or other services by using cookies or related technologies. First, we explain this technology in a general manner (A.), second, how we use this technology (B.) and, finally, we provide you with an overview of the services we use specifically (C.). Please also consult our Privacy Statement, which describes the collection, use, disclosure, transmission and storage of personal information collected about users and/or visitors to our website.

A. WHAT ARE COOKIES AND RELATED TECHNOLOGIES?

A cookie is a small text file placed on your computer or device by your internet browser when you access and/or use a website. This cookie (text file) can later be read by our web server or third parties.

Cookies are used, among other things, to identify your browser. They also enable us to recognize you as the same user who has previously visited our website. At the same time, cookies allow us to connect your use of our website with other information about you, such as your visitor information for the website (see the Privacy Statement).

Cookies can be "essential cookies" or "tracking cookies".

Essential cookies: These cookies enable basic functions and are necessary for the proper functioning of the services.

Tracking Cookies: These cookies can be marketing cookies or external media cookies. Marketing cookies are used by third parties or publishers to display personalized advertisements by following visitors across web pages.

Content from video platforms and social media platforms are blocked by default. If cookies from external media, so-called external media cookies, are accepted, access to this content no longer requires manual consent.

B. FOR WHAT DO WE USE COOKIES AND RELATED TECHNOLO-GIES?

We use cookies (or related technologies) to improve the efficiency of your use of the website and our services. This also includes enabling and optimising Al-powered features on our platform, such as automated dialogue flows, context-based responses, personalised recommendations, and analysis of aggregated usage patterns to improve our Al models. Where possible, such processing is carried out using anonymised or pseudonymised data.

We use different categories of cookies and related technologies, which are briefly explained here:

1. Essential Cookies (absolutely necessary)

These cookies are necessary for the functioning of the website and cannot be disabled in our systems. Usually, these cookies are only set to respond to actions you take, such as setting your privacy preferences or logging in or filling out forms.

You can adjust your browser so that it blocks these cookies and informs you about their installation attempt. Please note, however, that if you block them, some parts of the website will no longer function or will not function properly.

2. Performance cookies (tracking cookies)

Performance cookies collect information about the way a website is used, for example which pages you as a visitor visit the most, and whether you receive error messages from a page. The information collected is aggregated and anonymous. These cookies are only used to improve the performance of a website and therefore the user experience.

3. Targeting cookies (tracking cookies)

These cookies may be set by our advertising partners on our website and may be used by the advertising partners to profile your interests and show you relevant ads on other websites.

If you block these cookies, you will not receive targeted advertising anymore.

4. How can I manage these technologies?

With this cookie policy, we want to inform you that you have the possibility to block certain types of cookies. The cookie privacy settings can be managed in your browser. You can prevent the installation of cookies by means of the appropriate settings. However, we would like to point out that if you block certain cookies, you may not be able to use all of the content of this website to its full extent.

1. Services provided by Google

a. Google Analytics

In short: Google cookie for the analysis of web pages. This cookie generates statistical data on the use of the website by visitors.

In detail: Google Analytics is a web analysis service operated by Google Inc, 1600 Amphitheatre Parkway, Mountain View, CA 94043, USA (hereinafter "Google"). Google Analytics uses cookies, *i.e.*, text files ,which are stored on your computer and enable the analysis of your use of the website. b. Google Tag Manager

c. LinkedIn
